

Salient features of Stray Vacancy Round for NIA(DU) seats

First allotment phase (SVR-I)-for vacant seats	<ul style="list-style-type: none">• Registration & Choice filling available• No up gradation available from previous rounds
The vacant/not reported/withdrawn seats available after the reporting period of SVR-I will be considered during the second allotment for those candidates who have not been allotted any seats through SVR-I. The second allotment will be purely based on the choices locked by the candidates/locked as per server time during the choice-filling period of the First allotment phase SVR-I.	
Second allotment phase (SVR-II)	<ul style="list-style-type: none">• No Registration available.• No Choice filling available.• Allotment of seats will be based on merit and preferences of the candidate submitted during the choice-filling period of the first allotment phase. (SVR-I)

NOTE:

- Eligible candidates who wish to participate in SVR-I & II need to make a calculative decision before participating, as once they are allotted a seat in SVR-I&II of AACCC-PG Counseling they must join the SVR-I&II allotted seat.
- All candidates who wish to participate in SVR-I & II are required to complete the Undertaking form and send it to pgcounselling@nia.edu.in without fail. (Annexure –I)

ELIGIBILITY CRITERIA FOR CANDIDATES PARTICIPATING IN THE STRAY VACANCY ROUND (SVR-I&II) FOR NIADU SEATS

1. Only AIAPGET-2025 qualified candidates who have registered in the 1st/2nd/3rd Round of NIA-PG counseling are eligible to participate, provided that,-
Candidates who have not been admitted to any of the seats through 1st, 2nd, 3rd and Stray rounds AACCC-PG counseling or counseling conducted by State/UTs and NIA.
2. Candidates who have not registered in the NIA-PG counseling and have not been admitted to any of the seats through State/UTs counseling are eligible to participate after registering on the NIA-PG Portal during SVR-I.
3. Round-1 non-joined/joined candidate who availed of Free Exit.
4. Round-1 admitted candidates who did not get an upgrade during R-2/not participated in R- 2 and availed of exit with forfeiture till 14.10.2025 can participate with full payment of Counseling fees.
5. Round-2 non-joined candidates who availed of exit with forfeiture of counseling fees can participate with full payment of counseling fees.
6. Round 2 admitted/upgraded candidates who availed of exit with forfeiture of counseling fees till 24.10.2025 can participate with full payment of counseling fees.
7. No Up gradation is Available in SVR-I & II.
8. All candidates who wish to participate in SVR-I & II are required to complete the Undertaking form and send it to pgcounselling@nia.edu.in without fail. (Annexure –I)
9. Candidates must join the allotted seat in SVR-I as per schedule; otherwise, they will become ineligible for any NIA-PG Counseling 2025 with forfeiture of Counseling fees.

Note: The candidates whose names are reflected in the ineligible list published on the AACCC-PG portal are ineligible to participate in the SVR-I & II
